

## Terms and Conditions

### Shop in Croydon and Win a Holiday Cruise!

1. 'Shop in Croydon and Win a Holiday Cruise!' promotion (the Promotion) commences at 12:00am (AEST) on Tuesday 1 December 2015 and concludes at 5pm (AEST) on Thursday 31 December 2015 (the Promotion Period).

2. The Promotion is promoted by Croydon Main Street Traders Association.

3. All entrants will be subject to, and will need to adhere to, the terms and conditions as set out by the Promoter and any future terms and conditions or alterations to these terms and conditions.

#### Prizes

4. The promotion prize pool has a total value of \$2,000 1 x \$1500 cruise ship voucher , and 5x \$100 shopping voucher from the Croydon Main Street Traders Association, which is valid for shops in the Croydon Main Street Shopping District.

The \$1500 cruise ship voucher must be redeemed by 30 March 2016 at any travel agent operating in Croydon Main Street Victoria (Flight Centre Croydon, Croydon Travel or Croydon Cruise and Travel). If the cost of the chosen cruise is greater than \$1500 the winner is required to pay any difference.

5. Participants may enter as many times as they like provided they spend 5x \$30 or more at any store or service at Croydon Main Street Shopping District (for list of traders visit [www.croydonmainstreet.com.au](http://www.croydonmainstreet.com.au)) during the promotion period.

6. The Prizes must be taken as offered and are not transferable, refundable or exchangeable for cash or kind and are subject to these terms and conditions.

7. The warranty on the goods and/or services obtained as a result of the Promotion remains the sole responsibility of the manufacturer/supplier of the Prizes.

8. If the Prizes are unavailable for whatever reason, the Promoter reserves the right to substitute the Prizes for prizes of equal or greater value, subject to any applicable statutory requirements.

#### How to Enter

9. To enter, participants must make a purchase of \$30 or more for any goods or services in Croydon Main Street Shopping District during the promotion period listed above. When making a purchase for \$30 or more participants can collect a sticker on an entry form. Participants must collect 5 stickers then complete the entry form and place the completed form in the barrel at any of the participating shops at Croydon Main Street Shopping District for the chance to win one of five \$100 shopping vouchers or the grand prize of a \$1500 cruise holiday voucher, which is chosen and arranged by the winner.

11. The Promotion is open to all persons (18+ age) except owners, employees, or contractors of any traders at Croydon Main Street Shopping District and their immediate families, sponsors of the Promotion and their immediate families; the contractors of tenants in Croydon Main Street Shopping

District and their immediate families. Immediate families means spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) and grandparents.

13. The **'Shop in Croydon and Win a Holiday Cruise!'** is run and sponsored by Croydon Main Street Traders Association

14. Winners will be randomly selected (the Selection) via the barrel draw by the president of Croydon Main Street Traders Association at 101 Main Street on Wednesday 6 January 2016, at 12 pm.

18. Winners will be notified that they have won by phone in the first instance and via email and/or mail thereafter by 8 January 2016. All winners must show a valid form of identification such as an Australian passport or an Australian drivers licence to collect the prize. They may asked to show evidence of all purchases (eg. receipt).

19. If the Promoter has not had return communication from any initial intended Winner (ie attempts to contact that Winner have met with failure) within three months then that person will no longer be entitled to a Prize. In such a case, a reselection will be conducted from the pool of entry forms at approximately 10.00am (AEST) on Wednesday 6 April 2016 at the Croydon Travel by the staff (the Reselection). Any winner of a Reselection is a Replacement Winner.

A Replacement Winner does not need to be present at the Reselection and will be notified that they have won by phone in the first instance and via email and/or mail thereafter within three business days of the Reselection.

23. Prizes will not be mailed out.

25. Any photos taken of winners remain the property of Croydon Main Street Traders Association and can be used in any way to further promote the Promotion and/or Roselands.

26. Any decision made by Croydon Main Street Traders Association in respect of the Promotion is final and no correspondence will be entered into.

27. No responsibility will be accepted for late, lost, incomplete or misdirected entries. Entries which contain incorrect contact details shall be deemed invalid. The Promoter reserves the right in its sole discretion to disqualify any participant who the Promoter has reason to believe has breached any of these conditions, or engaged in unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such a person are reserved.
